**PHYSICIANS/SURGEONS**

BABCOCK, James Roy, MD  
Jerome, Idaho

Cause of  
Action: Respondent's license to practice medicine in Idaho was disciplined by the Idaho Board for engaging in unethical sexual contact with a patient.  
Order: Respondent's license to practice medicine in Utah was placed on probation for five years subject to the same conditions that apply to his Idaho license.

Corpus Christi, Texas

Cause of  
Action: Disciplinary action was taken against Respondent's license in North Carolina for self abuse of a controlled substance.  
Order: Respondent's licenses to practice medicine and to prescribe and administer controlled substances were revoked effective 30 days from the date of the Order.

NEFF, Stanley Dilworth, MD  
Park City, Utah

Cause of  
Action: The Division was investigating circumstances regarding Respondent's controlled substance license and the unauthorized use of his Drug Enforcement Administration number by his wife.  
Order: Respondent agreed to voluntarily surrender his licenses to practice medicine and to prescribe and administer controlled substances. Respondent also agreed not to reapply for licensure for a period of five years.

SCHOW, Jan-Erik, MD  
Garland, Utah

Cause of  
Action: Respondent admitted to prescribing controlled substances to several patients in excess of what was necessary to treat their medical conditions while knowing the patients had a history of drug abuse. Respondent further admitted the Division had initiated an investigation based on the following allegations: (1) that Respondent diagnosed and cast fractures for patients in spite of the fact that several radiologists indicated the patients did not have fractures; and (2) that Respondent delivered infants contrary to established protocols.  
Order: Respondent's licenses to practice medicine and to prescribe and administer controlled substances were placed on probation for two years with conditions and restrictions.

Salt Lake City, Utah

Cause of  
Action: Respondent submitted false insurance claims for the purpose of receiving greater payments for patient visits from insurance companies to which he was not entitled. In January 2000, Respondent was convicted of four felonies with respect to making false statements regarding health care matters and making false statements to the government and mail fraud.

Order: Respondent's licenses to practice medicine and to prescribe and administer controlled substances had expired on April 30, 2000. Respondent voluntarily surrendered his residual rights to renews those licenses.

TURNER, Bryan Wesley, MD  
Sandy, Utah

Cause of  
Action: Between January and March 2000 Respondent employed a technician to operate a medical laser device to remove patients' unwanted hair. Respondent allowed this technician to treat patients with the laser device when he had not examined them and evaluated the efficacy of using the device on those patients.

Order: Respondent was ordered to pay a \$500 fine. Respondent's license to practice medicine was placed on probation for two years with conditions.

Cause of  
Action: Disciplinary action was taken against Respondent's dental license in Massachusetts.

Order: Respondent's license to practice as a dentist was placed on indefinite probation with conditions and restrictions. NOTE: Respondent's license to practice as a dentist expired on May 31, 2000.

Action: Respondent engaged in inappropriate conduct with a patient.

Cause of  
Action: Allegations that Respondent violated a Memorandum of Understanding that governed his license by engaging in negligent or incompetent practice in dentistry.

Order: Petition and Notice of Agency Action filed against Respondent were dismissed based on Respondent's agreement to let his licenses to practice as a dentist and to prescribe and administer controlled substances expire on May 31, 2000 and to not reapply for licensure for at least 3 years.

BRADY, Ryan Keith West Valley City, Utah	Amended Order:	The probationary restriction regarding Respondent shall practice only under the on-site supervision of a RN or a licensed physician in good standing with the Division was changed to allow Respondent to be employed in a dialysis unit without on-site supervision of a RN, but under the general supervision of a RN in good standing with the Division.
	Date:	July 17, 2000
COOK, Nancy Park City, Utah	Cause of Action:	Respondent stole Demerol from her employer for her own personal use. Respondent accounted for the drugs by falsifying patient records and documenting the drugs had been wasted. Respondent also forged the names of co-workers as having dispensed the drug and/or having witnessed the wastage. Respondent replaced Demerol with saline in five tubexes. The tubexes were later administered to patients for relief of pain.
	Order:	Respondent's license to practice as a registered nurse was revoked with a stay of enforcement on the revocation. Said license is suspended for six months beginning June 7, 2000 with conditions to be met during the suspension. Upon Division and Board approval to terminate the suspension, Respondent's license to practice will be placed on probation for five years with conditions.
	Date:	September 11, 2000
HIATT, Lori Kay St. George, Utah	Cause of Action:	Respondent failed to comply with probationary conditions which governed her license. Respondent fraudulently obtained controlled substances from her employer. Respondent failed to submit to random drug testing.
	Order:	Respondent agreed to voluntarily surrender her license to practice as a registered nurse.
	Date:	July 17, 2000
HILL, Rose A. Brigham City, Utah	Amended Order:	The probationary condition requiring Respondent to receive medical care from one prescribing physician was changed to allow Respondent to receive care from two prescribing practitioners, one for regular health care and one for psychiatric care.

West Valley City, Utah	Cause of Action:	Respondent admitted he lied on his 1995 application for licensure by failing to note criminal convictions for Lewdness with a Child, a Class A misdemeanor, in January 1990. Respondent was also convicted of a Moral Decency Crime in September 1997.
	Order:	Respondent agreed to voluntarily surrender his license to practice as a registered nurse and to not reapply for licensure for a period of five years.

JEWKES, Mindy Draper, Utah	Amended Order:	The probationary condition restricting Respondent's access to controlled substances was terminated.
	Date:	August 16, 2000

LEFAIVRE-KNUTSON, Julie Ann Green River, Wyoming	Reinstatement Order:	The probation on Respondent's license to practice as a registered nurse was terminated and said license was reinstated with full privileges.

MICHELSEN, Lois A. Salt Lake City, Utah	Amended Order:	The probationary condition restricting Respondent's employment was amended to allow Respondent to work for Superior Home Health in the office only. Respondent cannot care for patients in the home health setting.

ORANO, Lourdes Sterling Heights, Michigan	Cause of Action:	Respondent's license to practice nursing in Michigan was disciplined.
	Order:	Respondent's license to practice as a registered nurse in Utah was placed on probation with the same conditions and restrictions that apply to her Michigan license.

RYGG, Susan Jen Stockton, Utah	Amended Order:	The probationary condition restricting Respondent's access to controlled substances was terminated.

	Order:	Respondent's license to practice as a registered nurse was revoked with a stay of enforcement on the revocation. Said license was placed on probation for two years with conditions and restrictions. Respondent was also ordered to pay a \$250 fine within 90 days of the date of the Order.

Order: Respondent's license to practice as a pharmacy technician was revoked with a stay of enforcement on the revocation. Said license was placed on probation for two years with conditions.

Cause of  
Action: Respondent dispensed controlled substances without a valid prescription from an authorized practitioner. Respondent had not maintained a current drug inventory record. Order: Respondent's license to practice as a pharmacist was revoked for 5 years with a stay of enforcement on the revocation. Said license was placed on probation for 5 years with conditions and restrictions. Respondent's license to dispense controlled substances was revoked for 5 years with a stay of enforcement on the revocation. Said license is suspended for 6 months beginning from June 22, 2000. Following the period of suspension, said license shall be placed on probation for the remainder of the probationary period affecting Respondent's pharmacist license. Respondent was also ordered to pay a \$2,000 fine within 90 days from the date of the Order.
