**MINUTES:**

The Board reviewed the minutes for March 2, 2006. Ms. Price motioned to accept the minutes with the requested changes. The motion carried unanimously.

**DISCUSSION ITEMS:**

Proposed Rule Change- Daniel T. Jones

The Board discussed in detail the proposed rule changes, noting the Board's concern to change the length of time a temporary is issued from its previous meeting needs to be re-evaluated as the National Association will not give the exam more than once every two (2) years. After discussing this in detail the Board decided to change the rule for temporary licenses to expire in thirty five (35) months

Pass/Fail Temporary License Extensions-  
Daniel T. Jones

The Board discussed in detail its concerns when an applicant fails the national exam more than two (2) times as this could have them working with a

temporary license for seven (7) years. After further discussion the Board decided to change the rules as follows, noting there are no guarantees a third (3<sup>rd</sup>) temporary license would be approved.

If an applicant fails the National exam more than two (2) times, before a third (3<sup>rd</sup>) temporary may be issued the applicant must:

1. Request to meet with it at its next regularly scheduled meeting;
2. Must submit proof of “active candidate status” with the National Association; and
3. Must submit documentation of extenuating circumstances why they failed the exam two (2) times.

Mr. Jones stated he will make the changes and e-mail copies for the Boards review. Mr. Jones stated these changes are minor and would not require a public hearing.

The Board briefly discussed continuing education and decided to make no changes at this time.
