TOPICS FOR DISCUSSION

Swearing in of Tonya Bailey:

Education Committee report:

Ms. Brown reported that CEU is now part of Utah State University and the name will be Utah State University-CEU. Committee members made a recommendation to accept transcripts from Utah State University for CEU nursing graduates. All Board members voted in favor of the motion. Dr. Hobbins reported Education Committee members have recommended letters of warning be sent to those nursing education programs that are out of compliance with the Nurse Practice Act and Rules. Mr. Allred made a motion to have the Education Committee take appropriate action including sending out letters of

warning, issuing fines and placing a program on probation without having to bring them before the Board. If there is unusual action being considered, the Committee would bring the recommendation before the Board. Ms. Jeffries seconded the motion. All Board members in favor of the motion.
