**NOTICE OF AGENCY ACTION
TO REVOKE LICENSE
FOR FAILURE TO REPLACE
QUALIFYING AGENT**

The Division of Occupational and Professional Licensing ("the Division") hereby files this Notice of Agency Action to determine whether a basis exists to revoke your license to practice as an alarm business or company for failure to replace your qualifying agent

Said action is based upon Division records which show that the qualifying agent, David Wright, for your license # 7763730-6501 is no longer associated with you and you have failed to replace the qualifying agent within 60 days as required by Utah Code Annotated 58-55-304(6) Division records indicate the qualifying agent ceased association with you on or before October 28, 2010

The adjudicative proceeding designated herein is to be conducted on an informal basis, meaning that you are not entitled to a hearing. The decision in this matter will be based upon a review of the Division records and any response filed.

Within thirty (30) days of the mailing date of this notice, you are requested to file a written response with the Division. The response you file may be helpful in clarifying, refining or narrowing the facts and the violation alleged herein. You may represent yourself or be represented by legal counsel, at your own expense, at all times while this action is pending. Your legal counsel shall file with the Division an Entry of Appearance and until that Entry of Appearance is filed, the presiding officer will deal directly with you.



At the expiration of your deadline to submit a response, and without further notice to you, the presiding officer will make an informal review of the record in this matter and make a determination of whether you have violated the requirement under Utah Code Annotated 58-55-304(6) and 58-55-502(5) to replace the qualifier within 60 days.

The maximum administrative sanction in this case is revocation of licensure.

Please conduct yourself accordingly.
