ADMINISTRATIVE BUSINESS:

MINUTES:

A motion was made by Bill West to approve the minutes from the May 5, 2009; May 19, 2009 and June 2, 2009 meetings for the Architectural Advisory Committee as written. The motion was seconded by Dave Lewis and passed unanimously.

Approval of the minutes from the June 2, 2009 joint meeting for the Unified Code Analysis Council was deferred until the next meeting as there was not a quorum present.

DISCUSSION ITEMS:

**REVIEW PROPOSED AMENDMENT
FOR 1008.1.8.6 DELAY EGRESS LOCKS**

Those present discussed delayed egress locks. Following a discussion by all present, the committees suggested that the Salt Lake Department of Airports should come back with a new or rewritten proposal or look into alternate means.

A motion was made by Cary Campbell to disapprove and delete the previously approved proposals for 1008.1.9.7 for the 2009 IBC and 1008.1.8.6 for the 2006 IBC. The motion was seconded by Bill West and passed unanimously for the Architectural Advisory Committee. The Unified Code Analysis Council concurred.

**REVIEW 2009 INTERNATIONAL CODES
AND CURRENT AMENDMENTS**

A motion was made by Cary Campbell and seconded by Bill West to approve the recommendations that were previously made on amendments R156-56-801(5), (6), (7), (9), (10), (11), (13), (14), (27) through (36), and new amendments to 202 and 304.1. The motion passed unanimously.

RD Gatherum and Richard Kester spoke to the committees in connection with current amendment R156-

56-801(37). Following a discussion by all present, a recommendation was made by Brent Halladay to table the issue until the next meeting so a clarification of what a drip leg is can be drafted. Jim McClintic volunteered to work with Mr. Gatherum on a proposal.

Dan Jones pointed out that the drip leg requirement is also in R156-56-802(21) and that amendment needs to be considered at the same time. He also requested that they review R156-56-802(20).

At this point Dave Levanger left the meeting and the Architectural Advisory Committee no longer had a quorum.

The following is the unofficial recommendation from both committees on the review of the current amendments in R156-56-801:

- (29) change the subparagraph number from 5 to 6 and carry forward
- (57) carry forward
- (58) change section number to 3401.6 and carry forward
- (60) change section number to 3411.1 and carry forward
- (61) change section number to 3411.4.2 and carry forward
- (62) change referenced code section to 907.2.11 and 907.2.11.5 and carry forward

International Residential Code amendments in R156-56-802

- (1) modified section numbers, delete last sentence and carry forward
- (2) carry forward

The meeting adjourned at 11:15.
