**Instructions:** We often find that an application to change a name is in fact an attempt a transfer a registration to a different person or entity, who/which is required to apply for a new registration. Registrations are **not** transferable between persons or entities. An application for name change will be denied if the new name is actually a different person or entity than to whom the handyman registration was originally granted. An application for a DBA will be denied if the DBA is owned by a different person or entity than to whom the handyman registration was originally granted. Please carefully read the requirements listed. The name change will be processed and updated in our files for your handyman registration at no charge. If you want a copy of your handyman registration with the new name, please include \$10.00 for a duplicate registration.
