- Documentation of a two-hour suicide prevention training course.

INITIAL APPLICANTS WITH A UTAH CASUDC LICENSE

If applying for **Initial Licensure**, *in addition* to the items required for all applicants, you must submit the following:

- Supervision for Post Graduate Practice Hours form documenting 4,000 hours of practice. **Note:** If you are a Utah LSUDC and submitted at least 2,000 hours of experience when applying for UT LSUDC license you only need to document 2,000 hours;

INITIAL APPLICANTS WITHOUT A UTAH CASUDC LICENSE

If you do not currently hold a Utah CASUDC license or qualify for Licensure by Endorsement, in addition to the items required for all applicants, you must submit the following:

- Supervision for Post Graduate Practice Hours form documenting 4,000 hours of practice.
- Copy of the score report showing a passing score on the written National Association of Alcohol and Drug Abuse Counselors (NAADAC) National Certification Exam Level II or MAC. Exam information is available on [our website](#).
- Official transcripts documenting a bachelor's degree or higher and completion of the prerequisite courses in human growth and development across the lifespan and general psychology; **AND** official transcripts or certificate from an accredited institution or higher education verifying completion of the substance abuse education program that includes completion of at least 300 hours of substance use disorder related education and a supervised practicum of at least 350 hours. **Note:** Transcripts are considered "official" when they are sent directly from the school to DOPL or sealed in an envelope bearing the school's stamp/seal on the envelope flap.

LICENSURE BY ENDORSEMENT

If applying for **licensure by endorsement**, there are two options. *In addition* to the items required for all applicants, you must complete one of the following options:

Option 1: One Year of Active Licensure from a [Jurisdiction Deemed Equivalent](#).

- Official verification, showing active licensure in good standing for at least one year, from a jurisdiction designated by the Division as equivalent to Utah.
- If required, official transcripts and/or exam scores to demonstrate equivalency.

Option 2: 4,000 Hours of Active Licensure from any U.S. Jurisdiction

- Official verification of license from one or more states in which you are currently licensed. Verifications must cover the time period used to qualify for endorsement.
- Verification of Active Practice as a LASUDC in Another State Form found in this application. **NOTE:** You must have each employer complete a separate form, and the hours from all forms must total 4,000.
